Chair Report

Lookout tower grievances — Waiting on information from the negotiator through Mike Dempsey to find out what is happening with the time period between the start of the season and when the terms went back to the old arrangement. It doesn't look like there will be retro-pay as we had anticipated and we are not sure what is happening with the rest of the grievances re: daily meal allowances and wilderness allowance. Towers are closing for season and some are looking for answers.

Some lookout tower persons have taken it upon themselves to put together a proposal for wage compensation to be brought forward at next bargaining. Not all are in agreeance with this proposal but it is a good start. Twenty-one lookout towers have signed this proposal with an additional 6 being anonymous.

Fielding questions and emails from various people regarding the tower issues throughout the summer.

Local Chair Meetings – Missed June meeting but attended September Meeting. Main theme was getting members fired up for a fight and Mass job action.

Digital Platform – First opportunity to look at new Digital Platform was open to Local Chairs on Wednesday, will be next open to executive councils and then Chapter Chairs for email privileges. Members should be able to access the system on Friday. If you don't know your member number you're encouraged to get it soon as it's expected the resource number will be swamped on Friday.

Direct Action Training Course – Training on how to teach members to be involved in work-to-rule basics and interrupt work action in a legal manner. Expected to be a highly sought after course.

Member Engagement – Some ideas other Locals have used are using a draw of a \$200 MC/Visa card for everyone that has filled out their grey card, including those that have done so previously. Also using a similar campaign for everyone that has taken Intro to the Union Course (Higher amount of \$1000). If council is interested we could do this as a Local.

Government did not want to attend, but was forced to the table by the union. June 11 first day of arbitration and both sides presented. Union economists did very well in our presentation while presenting and during cross-examination. June 17: Day 2 was set for macro evidence and both sides presented info again. June 18: Government introduced bill 9. June 24-26: Union went back for more information regarding Bill 9. Union submitted injunction of Bill 9 to the court July 29. Injunction granted. August 29th went to court of appeal. Appeal granted by judges 2-1. Suspect going forward we will remain with same arbitrator; government will be able to submit blue ribbon report as evidence as of November 1st. Union will be able to rebut with their own evidence.
